## Important Instructions for Questionnaire Filling and Submission

- 8. Majority of questions in the questionnaire would require a "Yes/No" answer. Among the two options, please delete the irrelevant option.
- 9. There are also certain fact-based and open-ended questions. Please make sure that you read it thoroughly and furnish the information.
- 10. The last sub-section relates to the financial contribution of each LBFT. This is a very critical requirement for the study and should be filled with due diligence.
- 11. Please do not submit partially filled forms. Please ensure that only those questions that are not relevant to your department are left blank.
- 12. Strict instructions shall be given to all the departments to pay utmost attention to the correctness of details.
